

THANK EVANS - CHILDCARE FEES for PRIVATE CONTRACTS

As of Tuesday 1st April 2008

1. INITIAL REGISTRATION FEE £50.00

- i. To be included when returning the completed registration form
- ii. Contracts will also be charged an annual re-registration fee on the anniversary of the initial registration at the current rate
- iii. Where any registration is terminated and later restarted, the current registration fee will once again apply

1a. REGULAR CHILDCARE with or without light housework

Up to 20 hours per week	£10.80
21 – 40 hours per week	£9.80

- i. This fee applies once registered and only to Regular Contracts (please also see 1b and 3)

1b. AD-HOC CHILDCARE with or without light housework

	Until 12 midnight
Up to 20 hours per week	£11.80
21 – 40 hours per week	£10.80

- i. This fee applies once registered and to Ad-hoc Contracts, but also to Regular Contracts where extra help is required and the regular staff member is unavailable
- ii. This fee only applies where more than 48 hours notice is given (otherwise please see 3)

1c. TERM-TIME CHILDCARE with or without light housework

Up to 20 hours per week	£11.80
15 – 35 hours per week	£10.80

- i. This fee applies once registered and to Term-Time Contracts only.
- ii. This fee only applies where more than 48 hours notice is given (otherwise please see 3)

2. OVERNIGHT CARE (O/N) min. £50.00 per O/N

- i. While the child/ren are awake rates 1b or 3 apply
- ii. For O/N where night feeds or regular wakening is required, rates 1b or 3 apply
- iii. For the period of the O/N where the child/ren are asleep the rate will be dependant on individual circumstances, please call to discuss further.
- iv. Each visit will be subject to a minimum charge of £50.00. Please call to discuss further.
- v. Times and rates must be agreed PRIOR to stay and the client must be registered

3. CHILDCARE REQUESTED WITH LESS THAN 48 HOURS NOTICE

Up to 20 hours per week	£12.80
21 – 40 hours per week	£11.80

- i. This fee applies once registered and to Regular, Adhoc, and Term Time Contracts.

FURTHER INFORMATION APPLICABLE TO ALL OF THE CHILDCARE RATES ARE ON REVERSE

Further Information applicable to all of the Childcare Rates

- 1) For a full explanation of “Regular”, “Ad-hoc” and “Term-Time” please refer to the Terms of Business or call Thank Evans
- 2) Where a qualified AND experienced member of staff is essential and supplied, these fee’s will increase by 50p per hour.
- 3) All mileage incurred by staff members while on duty must be repaid by Client direct to the staff member, at a rate of 40p per mile. Staff member to write mileage incurred in the communication book.
- 4) In the case of the staff member having to travel further than 15 miles to location, the mileage must be paid by the client, for every mile over the first 15 miles and for BOTH directions of travel, at a rate of 40p per mile.
- 5) Rates may be subject to change and the client will be informed of new rates at least one month in advance.
- 6) The above rates apply for one month from the date of mailing, which is stamped at the top of this page. If the registration form is returned after this period of time, please call to confirm current rates.
- 7) Where evening babysitting is required, if the only staff member available does not have their own transport home, at the END of the duty a lift should be supplied or a taxi should be paid for by the CLIENT.
- 8) All hourly rates are subject to a minimum charge of the equivalent of 3 hours per visit.
- 9) “Light housework” is classed as the daily domestic chores that are done as an upkeep of the house and therefore does not include dusting, vacuuming, cleaning bathrooms, mopping floors or equivalent.
- 10) All fees are per hour for up to 2 children. Please add £1 per hour per additional child.
- 11) Any reduction in hours/cancellation within 48 hours the client will still be charged for original hours booked.
